Guatemala employment law allows for employees to receive up to 10 days/year paid holidays. Companies give up to 15 work days/year, after a year of uninterrupted service, to employees for holiday time off. Maternity leave is generous in Guatemala. The laws allow for female workers to receive 12 weeks (84 days) for maternity leave.

In Guatemala, labor law is considered a public order law such that minimum labor rights cannot be waived. These rights include: minimum salary or salary agreed with the employee, work schedules agreed upon, Christmas Bonus, Annual Bonus, 15 days of vacations, and severance for time served.
